



### **PERSONAL RELEASE FORM**

1. I hereby irrevocably authorise and grant the Electricity Generation and Retail Corporation trading as Synergy ("the Producer" which includes its successors and assigns) the right to:
  - a. take audio and visual recordings and photographic images of me;
  - b. edit the audio and visual recordings and photographic images of me to produce images, film recordings, television recordings, sound recordings, program/campaign/information packages, web campaigns (which may include other recordings and material), and/or other works derived from the recordings and photographic images of me (the "Recording");

  - a. the blurring, distortion, alteration, optical illusion or use in composite form of my Appearance, whether intentional or otherwise, that may occur or be produced as a result of the reproduction, communication or editing of the Recording; and
  - b. the Use of any personal, proprietary or other right that I may have (if any) in relation to the Recording.
3. I acknowledge that the Producer owns and shall own all rights, title and interest (including intellectual property rights) in the Recording and irrevocably and unconditionally assign to the Producer all rights, title and interest (including all present and future copyright and other intellectual property rights) in and to the Recording from the date of its creation.
4. I consent to the Producer doing any act in relation to the Recording that is permitted by this release, even if that act would, apart from this release, infringe any moral rights in the Recording (to the extent that I am entitled to assert any moral rights (as conferred under the *Copyright Act 1968* (Cth)) in the Recording).
5. I waive any right that I may have to inspect and/or approve the Recording or the advertising or printed or electronic copy that may be used in connection with the Recording, or to control the Use of my Appearance in the Recording, or the disclosure of the Recording.
6. I further acknowledge that the Producer is not obliged to Use the recording.

7. I warrant that I have full power to enter into this release and that the terms of this release do not in any way conflict with any commitment on my part.

References to "the Recording" in this release includes any and all edited versions made by the Producer.

References to "Use" in this release means: to use, reproduce, copy, publish and/or exploit; to mix, edit, duplicate, adapt, re-use and/or create derivative works; to assign, license and/or sub-license; to publicise and/or market; and/or to exhibit, perform, communicate, broadcast and/or distribute by any present or future media.
